Trafalgar Football Netball Club – Sponsorship Terms & Conditions

1. Code of Conduct & Behaviour

All sponsors, their guests, and associated patrons agree to adhere to the **Trafalgar Football Netball Club (TFNC) Code of Conduct** at all times while attending club events, match days, functions, and presentations. TFNC reserves the right to remove any patron whose behaviour is deemed inappropriate or inconsistent with club values.

2. Compliance With Club Policies

By signing a sponsorship agreement, sponsors acknowledge and agree that all **TFNC policies, procedures, and codes** apply to them and their guests.

These policies — including but not limited to Child Safety, Alcohol Management, Respect & Inclusion, Member Protection, and Social Media — are publicly available on the TFNC website.

3. Sponsorship Deliverables

TFNC will provide the sponsorship benefits as outlined in the selected package; however, specific deliverables (e.g., signage placement, event invitations, media exposure) may vary due to weather, ground works, scheduling, or league-wide requirements.

4. Use of Club Branding

Sponsors may only use the TFNC name, logo, or imagery with prior written approval from the TFNC Executive Committee.

Brand usage must be respectful and aligned with club values.

5. Payment Terms

Full payment is required prior to the commencement of the season unless otherwise agreed in writing. TFNC reserves the right to withdraw benefits if payment is significantly delayed or not received. Upon commitment to a sponsorship package, invoices will be issued in January of each year, with full payment required by the end of February unless otherwise agreed in writing.

6. Refunds & Cancellation

Sponsorships are non-refundable once the season has commenced.

If a season is shortened, interrupted, or impacted by factors outside of the club's control (e.g., league decisions, extreme weather, facility closures), sponsorship benefits may be adjusted at the club's discretion.

7. Privacy

Sponsor details will be stored securely and used solely for communication and promotional purposes directly related to TFNC.

Information will not be shared with third parties without consent.
